

Declaration

The Office of the Hungarian Design Council (hereinafter “OHDC”), which is an organisational unit of the Hungarian Intellectual Property Office (hereinafter “HIPO”) and is acting on its behalf, has begun to review the contact details in its possession. We need the confirmation of your earlier consent in order to be able to continue sending you the news, information, and invitations concerning OHDC and the events organised by OHDC.

Please read carefully the related information below, so that you could give your consent having read all the relevant information on the processing of your data by OHDC and on your rights in connection therewith.

The information deals with the circumstances relevant from the point of view of the General Data Protection Regulation of the EU (GDPR¹), since as of 25 May 2018 the processing of personal data is primarily regulated by the GDPR.

Information on the processing of contact data by the Hungarian Design Council

The personal data, primarily the name and e-mail address of the data subject, provided by the data subject, will be processed by OHDC. The purpose of processing is to provide information on topicalities and news relating directly or indirectly to HIPO or OHDC, and on the events organised by HIPO or OHDC, as well as to keep in touch for these purposes, and ensuring the possibility of sending invitations.

The legal basis of data processing is the consent of the data subject, and there is no obligation to give such consent; however, failure to give consent means that OHDC will not send information, notices, news, invitations etc. or keep in touch in this way.

Data processing is carried out by OHDC’s staff assigned to this task, but where necessary they may also use the services of processors, for example for mailing, graphic or printing office jobs. OHDC does not use automated decision-making procedures in connection with personal data.

Data processing will be done until the withdrawal of consent: OHDC will erase the personal data concerned from its register designated for this purpose, at the latest on the day following receipt of the declaration of withdrawal of consent.

Withdrawal of consent can be sent by email to the following address: mfti@hipo.gov.hu. The withdrawal of consent does not affect the lawfulness of processing before its withdrawal.

Any applicant may request access to his personal data, their rectification, erasure or the restriction of their processing, exercise his right to data portability in conformity with existing legislation, and may object to the processing of personal data concerning him or her. Anybody who considers that his or her rights as a data subject have been infringed as a result of the processing of personal data by OHDC, may request information from or lodge a complaint with OHDC or the Hungarian National Authority for Data Protection and Freedom of Information, or may seek judicial remedy in the cases provided for by the GDPR.
